

Risk Disclosure

FXMARKER is the trading name of Green Investment House Ltd. (“FXMARKER”) authorized and regulated by the Belize International Financial Services Commission (“IFSC”) under license # IFSC/60/287/TS/18.

FXMARKER may offer its clients a variety of financial instruments such as rolling spot foreign exchange transactions (“Forex”) and contracts for differences (“CFDs”).
